**JULIE KJORSVIK, CLERK OF THE BOARD** provided a Staff Report on the application to the Department of Commerce for Community Development Block Grant - Public Service Funds in the amount of \$85,070.00. The public was also encouraged to provide comments on the community action program's past performance and use of their 2020 CDBG funds. **JUDY PLESS, BUDGET & FINANCE MANAGER** encouraged the Board to approve the CDBG Public Service Funds Grant Application.
