- WHEREAS:** FEMA requires Board of County Commission adoption as part of the final plan approval process;





WHEREAS, the City actively participated in and endorsed in writing the Kittitas County 2019 Hazard Mitigation Plan update process;


WHEREAS, the City requested and received a formal Annex into the Kittitas County HMP.






